

PRIVACY POLICY

At RP Educational Trust, we are committed to protecting the privacy of our students and their personal information. This Privacy Policy outlines how we collect, use, and safeguard data related to the fees payment process. By using our website and engaging with our fees module, you agree to the terms of this policy.

SECTION 1 - INFORMATION WE COLLECT

When students or parents make payments through our fees module, we collect the following personal information as part of the payment process:

Personal Identification Information : Name, address, email, contact number.

Student Information-: Name of the student, student ID number, class/grade, program details.

Payment Information-: Payment details such as bank account number, credit/debit card information (processed through our third-party payment processor), transaction details, and history.

IP Address-: Automatically collected to help ensure the security of the payment system.

SECTION 2 - CONSENT

How Do We Obtain Consent?

When you provide us with personal information for processing payments or verifying your identity, we assume your consent to collect and use this information for that specific purpose only.

If we seek to use your personal information for any additional purposes, such as sending fee reminders or promotional offers, we will ask for your explicit consent.

How Do You Withdraw Consent?

SECTION 3 - DISCLOSURE OF INFORMATION

We do not sell, trade, or rent your personal information to third parties. However, we may disclose your information if: Required by law or court order.

You violate our terms or misuse the platform.

It is necessary to share the information with our service providers for operational purposes (e.g., payment processing, auditing).

SECTION 4 - PAYMENT PROCESSING

We use secure third-party payment processors to handle all transactions. These processors adhere to the standards set by the Payment Card Industry Data Security Standard (PCI-DSS). We do not store or access your full payment details (e.g., credit card numbers).

SECTION 5 - THIRD-PARTY SERVICES

Third-party service providers (such as payment gateways) have their own privacy policies. We recommend that you review their privacy policies to understand how they handle your personal information.

Some of these providers may be located in jurisdictions outside your country of residence, and your information could be subject to the laws of those jurisdictions.

SECTION 6 - SECURITY MEASURES

We prioritize the security of your personal information and use industry-standard encryption technologies and best practices to ensure your data is protected. We take appropriate steps to prevent unauthorized access, disclosure, alteration, or destruction of your information.

However, while we strive to protect your data, no transmission over the internet can be guaranteed 100% secure.

SECTION 7 - COOKIES

We may use cookies to facilitate your interaction with our fees module and to ensure a seamless user experience. These cookies help manage session details and are not used to personally identify you on other websites.

SECTION 8 - AGE OF CONSENT

By using our fees module, you confirm that you are either:

At least the age of majority in your province or state of residence.

If under the age of majority, you have obtained consent from your parent or guardian to complete the payment.

SECTION 9 - CHANGES TO THIS PRIVACY POLICY

We reserve the right to update or modify this privacy policy at any time. Any changes will take effect immediately upon posting. It is advised that you review this policy periodically to stay informed of any updates.
